MINUTES OF THE FIRE DISTRICT NO. 1 ANNUAL MEETING

Pursuant to the foregoing Warrant the inhabitants of Fire District No. 1, South Hadley, Massachusetts, met at the hour and place designated.

It took 41 voters 31 minutes to discuss and vote on the 39 articles on the warrant during the Annual Meeting on Wednesday, April 14, 2021 at PVPA – Pioneer Valley Performing Arts, 15 Mulligan Dr., South Hadley MA 01075

The following is the action taken on the articles:

ARTICLE 1. Voted unanimously to accept the report of the Prudential Committee as found on pages 1 thru 7 in the annual report dated for the fiscal year ending June 30, 2020.

ARTICLE 2. Voted unanimously to accept the report of the Board of Water Commissioners as published on pages 16 thru 22 of the Annual District Report for the fiscal year ending June 30, 2020.

ARTICLE 3. Voted unanimously to accept the report of the District Treasurer as found on pages 8 thru 15 in the Annual Report for the year ending June 30, 2020.

ARTICLE 4. Voted unanimously to fix the salary and compensation of the following elective officers of the Fire District No. 1 for the Fiscal Year beginning July 1, 2021as provided by Massachusetts General Laws, Chapter 41, Section 108: Moderator, Prudential Committee Members, Clerk/Treasurer, and Water Commissioners as follows:

- ARTICLE 5. Voted unanimously to raise and appropriate the sum of \$1,495,274, transfer \$100,000 from Free Cash and transfer the sum of \$740,256 from the Ambulance Reserve Fund for a total of \$2,335,530 to fund the Personnel Services account as detailed in the Prudential Committee FY22 budget document.
- ARTICLE 6. Voted unanimously to raise and appropriate the sum of \$270,200 for the Fire Department Other Expense account as found in the FY22 Prudential Committee budget document.
- ARTICLE 7. Voted unanimously to transfer from the Ambulance Reserve Fund the sum of \$211,000 for the Ambulance Other Expense account as found in the FY22 Prudential Committee budget document.
- ARTICLE 8. Voted unanimously to raise and appropriate the sum of \$137,900 for the Administration Other Expense account as found in the FY22 Prudential Committee budget document.
- ARTICLE 9. Voted unanimously to raise and appropriate the sum of \$3,000 for the Fire Department Air Compressor account.
- ARTICLE 10. Voted unanimously to raise and appropriate the sum of \$35,000 for the Fire Department Building Improvement account.
- ARTICLE 11. Voted unanimously to raise and appropriate the sum of \$10,000 for the Fire Department Major Equipment Repair account.
- ARTICLE 12. Voted unanimously to transfer from the Ambulance Reserve Fund the sum of \$4,000 to the Ambulance Computer System Account.
- ARTICLE 13. Voted unanimously to raise and appropriate the sum of \$10,000 for the Fire Department Fire Gear Replacement account.
- ARTICLE 14. Voted unanimously to raise and appropriate the sum of \$10,000 for the Fire Department Alarm Room Console Account.
- ARTICLE 15. Voted unanimously to raise and appropriate the sum of \$5,000 for the SCBA Account.
- ARTICLE 16. Voted unanimously to raise and appropriate the sum of \$10,000 for the Web site/Information Technology Account.

- ARTICLE 17. Voted unanimously to transfer from Free Cash the sum of \$120,000 for the Debt Principal Account to fund the annual principal payment for the Fire Department ladder truck.
- ARTICLE 18. Voted unanimously to raise and appropriate the sum of \$28,350 for the Debt Interest Account to fund the annual interest payment for the Fire Department ladder truck.
- ARTICLE 19. Voted unanimously to transfer from Free Cash the sum of \$60,000.00 to the Fire Vehicle Stabilization Account.
- ARTICLE 20. Voted unanimously to transfer from the Ambulance Reserve Fund the sum of \$85,000 to the Ambulance Stabilization Account.
- ARTICLE 21. Voted unanimously to transfer from Free Cash the sum of \$300,000 to fund the Fire Department Other Post-Employee Benefits (OPEB) Fund.
- ARTICLE 22. Voted unanimously raise and appropriate the sum of \$436,345 and transfer \$100,000 from Free Cash for a total of \$536,345 to be paid by the District Treasurer to the Treasurer Custodian of the Hampshire County Retirement System.
- ARTICLE 23. Voted unanimously to raise and appropriate the sum of \$414,224, transfer \$100,000 from Free Cash and transfer the sum of \$54,000 from Ambulance Reserve for a total of \$568,224 for the payment of seventy-five (75%) percent of the fire department health, dental and life insurance benefits.
- ARTICLE 24. Voted unanimously to authorize the District Treasurer, with the approval of the majority of the Prudential Committee, to make legal and prudent investments of the District's funds all pursuant of the terms, conditions and restrictions of all relevant sections of Massachusetts General Laws Chapter 167.
- ARTICLE 25. Voted unanimously to authorize the district treasurer with the approval of the prudential committee, to borrow money from time to time in anticipation of revenue for the financial year beginning July 1, 2021 in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.
- ARTICLE 26. Voted unanimously to allow the Prudential Committee to sell surplus equipment or material.
- ARTICLE 27. Voted unanimously to authorize the Prudential Committee to apply for, accept and expend any State or Federal Grants.

Article 28. Voted unanimously to appropriate the sum of \$1,866,185.00 to defray the operating cost of the Water Department and to meet said appropriation:

Article 29. Voted unanimously to appropriate the sum of \$240,000.00 for the Health, Dental and Life Insurance Account and to meet said appropriation, transfer the sum of \$240,000.00 from the Water Available Surplus, as follows:

Article 30. Voted unanimously to appropriate the sum of \$152,361.00 for the Retirement Account, and to meet said appropriation, transfer the sum of \$152,361.00 from the Water Available Surplus.

Article 31. Voted unanimously to appropriate the sum of \$100,000.00 for the Water Tank Stabilization Fund and to meet said appropriation, transfer the sum of \$100,000.00 from the Water Available Surplus.

Article 32. Voted unanimously to appropriate the sum of \$5,000.00 for the Water Main Leak Detection Account, and to meet said appropriation, transfer the sum of \$5,000.00 from the Water Available Surplus.

Article 33. Voted unanimously to appropriate the sum of \$50,000.00 for the Water OPEB Trust Fund, and to meet said appropriation, raise the sum of \$50,000.00 from its water Available Surplus.

Article 34. Voted unanimously to appropriate the sum of \$3,000.00 for the Leaping Wells Watershed Account and to meet said appropriation, transfer the sum of \$3,000.00 from the Water Available Surplus.

Article 35. Voted unanimously to appropriate the sum of \$203,800.00 for the Newton St. Amortization, and to meet said appropriation, raise the sum of \$203,800.00 from its water available surplus.

Article 36. Voted unanimously to appropriate the sum of \$20,000.00 for the Critical Infrastructure Stabilization Fund, and to meet said appropriation, raise the sum of \$20,000.00 from its Water Available Surplus.

Article 37. Voted unanimously to appropriate the sum of \$10,000.00 for the Water Meter Replacement Account and to meet said appropriation, raise the sum of \$10,000.00 from its Water Available Surplus.

Article 38. Voted unanimously to appropriate the sum of \$8,000.00 for the SCADA system Account and to meet said appropriation, raise the sum of \$8,000.00 from its Water Available Surplus.
