STATUS OF DISTRICT MEETING:

Prudential Chair Kevin Taugher opened up the meeting and stated the District could hold the Annual Meeting at the Kendall Field House at Mount Holyoke College on Thursday, June 18th. Kevin stated the Town of So. Hadley is considering holding their Annual Meeting at this location on June 17th. Kevin Taugher noted that Town Administrator Mike Sullivan is looking into it with the Governor and noted that if we held our meeting the day after the Town the tables and chairs would already be set up. Kevin stated that the facility holds 150+ people and we would be able to be 6-8 feet apart and wear masks if required. BYLAW AND POLICY ADHOC

ADVISORY COMMITTEE (BPAAC) FINAL

DRAFT RECOMMENDATION: Bruce H. Perron opened up the discussion about the final draft of the By Laws by stating he would like clarification on Article 3, Section 2 that states that Water Board can call a meeting at any time. Bruce is concerned that the Water Board could call a meeting for a random unrelated water subject and vote on it. Jeff Cyr reminded Bruce that ultimately the District voters could vote on a large purchase or change in District policy. Attorney Mark Beauregard stated that this committee has met at least 11 times for no less than 2 hours each meeting to comb over these new By Laws and that legally anyone can call a public meeting it does not mean that something will get passed without a public vote. Kevin E. Taugher had several small areas he would like the committee to go over and look at or revise, some are just grammatic errors and some are rewording. After lengthy discussion of the many areas Kevin is concerned with, it was decided that Kevin will forward his areas of correction and concern to Jeff Cyr and he will review with the By Law Committee at the next meeting. The goal is to present the final Bylaw's to the residents at the Annual Meeting.
