BRITTANY RD. WATER MAIN PROJECT UPDATE:

Jeff Cyr notified the Board that the water main project for Brittany Road is going well. The Maintenance crew has 2 remaining tie-ins and final paving left to complete the project. Jeff expects the Maintenance Crew will be done within the

next 2 weeks.

MWRA CONTRACT MEETING 5/4/2017:

Jeff Cyr informed the Board that our contract with the MWRA is up in December 2017. The Chicopee Superintendent, Alan Starzyk called for a meeting for the three CVA communities (South Hadley, Wilbraham, Chicopee) to discuss the upcoming contract renewals for all CVA communities. Jeff noted during the meeting they discussed ways they could change or improve the existing contracts. No real issues came up as a result of the meeting. Jeff felt as though our new contract should include the revision forma few years back regarding new customers along the 16" pipeline Jeff also thought we should have the requirements and fees in our contract in the event a merger issue

arises within the next ten years

TURBITITY ISSUE AT QUABBIN:

Jeff Cyr reported to the Board he was notified by the DEP we need to take a full round of coliform samples for today and Friday as a result of the replacement of the screens on the intake pipe going to the CVA. The work has created turbidity in the system and the DEP is concerned about water quality. We were

scheduled to take our regular samples on Monday, so this is in addition to that..

Jeff will keep the Board updated.

CAMDEN STREET WATER MAIN BREAK 4/25/2017:

Jeff informed the Board there was a water main break on Camden Street on April 25, 2017 on the 8" main in front of house #108. The leak was on the corporation at the main and when it was excavated, the water main let go due to poor soil conditions at that location. Jeff feels strongly that the main should be placed on our capital plan for replacement.

PITTROFF AVENUE BREAK 5/5/2017:

Jeff Cyr reported to the Board that an old leaded corporation valve blew out of the

water main on Pittroff Avenue in front of house #155.
