# Wednesday, October 7, 2019 – 4:00 PM Meeting Minutes Water Department Meeting Room 438 Granby Road South Hadley, MA 01075

In Attendance: Water Department Superintendent and Bylaw & Policy Adhoc Advisory Committee (BPAAC) Chair Jeffrey Cyr, Prudential Committee (PC) Chair Bruce Perron, Board of Water Commissioners (BOWC) Chair William Schenker, Interim Clerk Treasurer Ira Brezinsky, Chief Robert Authier, District Moderator and Counsel Mark Beauregard, Community Resident Mitchell Malinowski

### **CALL TO ORDER**

Cyr called the meeting to order at 4:00 PM

### **APPROVAL OF MINUTES**

**Motion:** Schenker moved and Authier seconded to approve the minutes of 9/25/19. Motion carried 6-0. (Beauregard did not vote as he arrived at 4:06 and has not yet been officially appointed to the BPAAC by the Prudential Committee.)

### ONGOING DISCUSSION OF BYLAWS AND POLICIES

Cyr presented a draft of bylaws that were taken from the current SHFD 1 bylaws and Cotuit Fire District bylaws. He explained that he had made certain edits to the merged document and suggested that the document be used as a starting point for future discussion. The document has been color coded to show the origination and status of certain parts of the draft as follows.

- Blue = Existing SHFD1
- Black = Cotuit with modifications
- Yellow = Proposed revised language to review
- Red = Language regarding establishment of Policy Advisory Committee

Cyr suggested reviewing the first half of the draft (9 pages) at the next meeting.

A discussion ensued regarding how to treat "Strong Chief/Weak Chief" language (MGL Chapter 42a). The current Chief works under Strong Chief statute, however the current rules indicate that Weak Chief will take effect at such time a new Chief replaces the current Chief.

Beauregard asked what the most pressing issues are. The following is a partial list of issues.

- Beauregard: Status of Clerk Treasurer (elected versus appointed)
- Beauregard: Strong Chief/Weak Chief
- Cyr: Updating of policies and determination of how various policies are derived, approved and implemented
- Perron: Establishment of Appointing Authority Committee in the event that an elected official leaves mid-term and needs to be replaced
- Perron: Clarification of language in sections 10, 13 & 14e of the current bylaws

- Authier: Modification of language to comport with the Collective Bargaining Agreement (CBA) and Mass General Law (MGL), i.e. roles and responsibilities, longevity, fines, etc.
- · Perron: Health insurance eligibility
- Schenker: Recall provision What would be the standard? What would be the process?
- Beauregard: Distinguish between general revision of language for clarification purposes versus substantive change(s) in policy or bylaw
- · Authier: Differentiation of bylaw versus policy
