March 6, 1636 hrs. FD responded to 100 Abby Street for a suspicious package, SHPD already on scene, Massachusetts State Police Bomb Squad was notified and responded, The object was deemed safe and all units cleared.

March 6, 1802 hrs. a residential fire alarm call was updated to a Box Alarm for smoke inside the structure. The investigation discovered that the fire was inside an electrical panel in the basement. There was no extension to the structure. SH Electric Light was called and responded.

March 21, at 1404 hrs. responded to a vehicle that struck a pole at Memorial Drive and Abby Street, Two injuries, patients were transported to hospital.

March 21, at 2048 hrs. responded to the 202 Rotary for a vehicle rollover. The patient self-extricated. The patient was transported to hospital.

March 22, at 0947 hrs. a box alarm was struck for a structure fire involving an oxygen tank. Units arrived to find the fire had been extinguished, but a civilian had been injured. The patient was transported to hospital. The cause of the fire was improper use of smoking material.

March 24, at 1322 hrs. a box alarm was struck for a structure fire at 15 Canal Street. Units arrived to find heavy fire on the front and left side of the structure. One person was assisted from the apartment. A second alarm was struck at 1332 hrs. for extra manpower to the scene. Granby Fire went to the scene, while Holyoke Fire covered the station. There were minor injuries of 2 firefighter, both of whom remained on scene. The cause of the fire was improper disposal of smoking material.

March 29, at 1721 hrs. a box alarm was struck for a possible house fire at 35 Bardwell Street. Units arrived to find smoke coming from the rear of the structure. Further investigation found a fence on fire away from the structure. The cause of the fire was improper disposal of ash.
