Ambulance Report

KT- reiterated his concerns about the trends in the ambulance payables and tracking those trends. The committee is still not receiving the level of detail in the ambulance reports that we have been asking for, for quite some time.

Chief had mentioned that he based the ambulance budget on the average collected receipts which he said was about 54k per month.

Budget Discussion

KT- commented on the recent changes to the fire dept. portion of the retirement contribution

KT- presented a spreadsheet on the history of free cash. There appears to be a trend in turn backs to free cash. He said he felt comfortable the district could take additional free cash to backfill the retirement contribution.

The committee went through the budget looking for additional areas that could be cut. We also discussed the tax rate impact and trying to hit a moving target of about 54k. KT presented a chart in declining values and the impact of a rising fore tax.

After some adjustments were made, coupled with some conservative assumptions we appear to be fully solvent. Figured the budget increase for FY14 to be an increase of about 3.1%
