K. Taugher said to FF Choquette that if any discussion of the suspension were scheduled to take place, it would happen at a posted meeting of the PC and that she would receive at least 48 hours' notice from Chief Authier.

Chief Authier identified FF/Medic W. O'Rourke and FF/Medic B. Morris actions responding to an injured basketball player were noted to Chief Authier as having done a great job immobilizing the injured player that may have avoided serious damage to the player's nervous system.

K. Taugher moved and R. Miner seconded a motion for Chief Authier to send a commendation letter to both FF/Medics and place a copy of the commendation in their personnel file. Motion passed 3-0.
