Ed Wall and Raymond Miner stated that in the private business no one walks into a position at the

current salary. The Prudential Board was asked to meet with the Water Commissioners on this matter since the Treasurer/Clerk position is an elected district position. There will be an emergency meeting at the Water Department Thursday, April 7, 2011at 7:00pm with both boards. Attorney Mark Beauregard will be invited to attend.
